#### ORDER

WHEREAS, the institution i.e. S.S. College of Education, 3 K 47, Vinayak Marg, Sector No. 5, Hiran Magri, Distt. Udiapur-313001, Rajasthan was granted recognition by the NRC vide Order No. F.NRC/NCTE/F-7/RJ-1043/2007/24610-16 dated 06.08.2007 for conducting B.Ed. course of one year duration with an annual intake of 100 (One Hundred Only) students.

AND WHEREAS, the recognition was also granted to the institution by the NRC vide Order No. F.NRC/NCTE/RJ-1816/2008/63026-32 dt. 02.09.2008 for conducting D.El.Ed. course of two years duration with an annual intake of 50 (Fifty Only) students.

AND WHEREAS, the recognition granted to the institution for B.Ed. and D.El.Ed. programmes was withdrawn by the NRC vide Order No. F.NRC/NCTE/RJ-1043/163<sup>rd</sup> Meeting/2010/27301 dated 08.09.2010 on the following points:-

- The Institute has shifted without the permission of NRC, NCTE and adopting the procedure.
- The University letter regarding the nomination of expert on the selection committee of B.Ed. has not been submitted.
- Photocopy of Stock register for purchase of Computers has not been submitted.
- The total number of titles is not as per NCTE norms for B.Ed.
- The total number of titles is not as per NCTE norms for D.Ed.
- The B.Ed. and D.Ed. Faculty details are not given on the College website as per NCTE norms for B.Ed. and D.Ed.

AND WHEREAS, the institution filed S.B. Civil Writ Petition No. 8066/2010 before the Hon'ble High Court of Judicature for Rajasthan at Jaipur Bench, Jaipur. The Court passed an Order dt. 25.08.2010 in the said writ petition.

AND WHEREAS, in compliance of the Court Order, the case was considered by the NRC in its 168<sup>th</sup> meeting held on October 05-08, 2010 and the Committee decided that VT may be sent U/S 17 of the NCTE Act, 1993 as per Court direction. Accordingly, the inspection of the institution was conducted under section 17 of NCTE Act, 1993 on 15.10.2010.

AND WHEREAS, the VTR was considered by the NRC in its 171st meeting neld on October 28-29, 2010 and the Committee decided that a fresh show cause notice under section 17 of the NCTE Act, 1993 be issued to the institution. Accordingly, show cause notice dt. 18.11.2010 was issued to the institution.

AND WHEREAS, the institution submitted its reply dt. 27.04.2015 to the NRC office on 27.04.2015 in response to the aforesaid show cause notice. The case was considered by the NRC in its 237<sup>th</sup> meeting held on May 11-13, 2015 and the Committee decided the following:-

The recognition of the institution for B.Ed. and D.El.Ed. courses will continue as the reply given on 27.4.2015 by the
institution in response to show cause notice and report of the VT is satisfactory.

NOW, THEREFORE, the recognition/permission of the institution is hereby restored for B.Ed. and D.El.Ed. courses. The name and address of the institution be read as "S.S. College of Education, Aaraji No. 8222 to 8224, Jhamar Kotada Road, Umarada, Distt. Udaipur, Rajasthan."
